

GRK FASTENERS CAMO HAT AND CAN COOLER SWEEPSTAKES

OFFICIAL RULES

1. **Sponsor.** This sweepstakes is sponsored by Illinois Tool Works Inc., an Illinois corporation, the headquarters of which is located at 155 Harlem Ave, Glenview, IL 60025 (“**Sponsor**”). By entering, you agree to these official rules and the decisions of the Sponsor, which are final and binding. This contest is not sponsored, endorsed, or administered by Facebook.
2. **Eligibility.** The GRK Fasteners Camo Hat and Can Cooler Sweepstakes (“**Sweepstakes**”) is open only to individuals who are legal U.S. residents, 18 years of age or older with pre-existing Internet access and Facebook accounts. You must complete all required information to be eligible to enter to win a prize. Entries must be submitted between September 23, 2019 at 12:01 am and September 30, 2019 at 11:59 pm Central Time. Normal Internet access and usage charges imposed by your online service provider may apply and will be your sole responsibility. All information provided is provided to Sponsor, and not to Facebook.

Limit one sweepstakes entry (“**Entry**”) per person. Additional entries will be disqualified, and Sponsor reserves the right to disqualify any person that submits multiple entries.
